A lot of hard work and good planning created European championships of good technical and social standard in 2019. Statistics show that all together 2058 (*2138) lifters took part in European championships in year 2019.

From 2021, the European Bench press championships will be combined into one championship for all age categories and both equipped and classic. This will be a championship with up to 600 participants.

The European Classic Open, Junior and Sub-juniors needs 10 days of lifting. Such a long championship means a heavy workload for the organizer. The EC has decided to split this organization in two different championships from 2023. One championship for Juniors and Sub-Juniors and another for Open.

Antidoping.

In year 2019, EPF made 142 (129 in 2018) doping tests at European championships. This means that about 7% of all lifters were tested. Unfortunately, 4 lifter tested positive - and have received suspensions from 2 month to 8 years.

IPF focus now on Out of competition testing as instructed by WADA because this kind of testing can be done at any time throughout a year independent of championships. EPF will continue to make tests at European competitions and focus on record setters, medal winners and random tests.

4 positives in 2019 is a too high number. Our member federations should focus on anti-doping if they want powerlifting to reach IOC status, but most important is to take care of the lifters health. Fair play and a healthy sport should be in focus for all our members.

I encourage lifters, coaches and officials to joint the anti-doping seminars organized in conjunction with EPF and IPF championships.

High standard of European lifters.

EPF is one Region of total 6 IPF Regions and European lifters won more than 50% of the medals in World championships in 2019. This high level is a result of hard work by the athletes but also a big credit to European coaches and training systems as well as the leadership in national clubs and federations. You should all be very proud of this success!

Strategic plan.

The Executive board have every year worked out GA proposals and made up documents and routines to improve the organisation of powerlifting in Europe and to prepare for the future.

The document named "Strategic plan" was introduced in 2016 and is updated regularly.

In this document the federation's views and plans for the future are included and helps us to work towards common goals. This document is our guideline for the coming years.

Marketing strategy.

The Executive members, in co-operation with Eric Rupp and Richard Haywood, work to line out all information needed to present EPF as an attractive partner for sponsors and collaborators. A document focusing on the EPF benefits and a short video showing the powerlifting sport is worked out and is the tool to reach sponsor companies.

Such information are necessary because any sponsor must know what benefit his company will get from EPF if the company puts money or recourses into the federation. Any sponsor looks at how he can get his investments at least double back.

5) EPF Account 2019 (All values are in Euro)

Treasurer Report 2019

First of all I want to say thank you because it was a pleasure to work with all the national federations. You paid all invoices on time and I did not make any late payment penalty invoices. For a treasurer it is perfect. Thank you. We have a very good balance with a surplus of 24 354.84 € and we have several reasons for this good result.

- In first we controlled the expenses and they did not exceed the budget, except :
 - the doping cost but this money only passes from the EPF to go to the IPF and we paid 2 old invoices with antidoping found.
 - The computer secretary because Sacha bought some equipment to be better and better.
- For the incomes, we had 2,216 lifters instead of the 2,000 planned so we have more money. Classic Championship are in full development and it is very good for our finances.
- Also, we had more sponsors than expected and I thank all our partners who represent nearly 20% of our budget.
- And finally we charged 11 750 € with penalty for no referee or no presence at the Technical Meeting instead of 0 €.

For this last point I am very disappointed.

If we have instituted penalties for these 2 points it is not to take money from national federations but it is only **to make good conditions for lifters**.

As you can see we have enough money for the moment. Of course we need money to continue our development but we do not need more for 2020.

On the other hand we need enough referees to keep them efficient and we need to know if all the registered lifters will be there to facilitate the work of the referees and so that they can give the most score sheets quickly possible to lifters.

Please for the organizer, for EPF and **mostly for your lifters**, send referees and give all information in time at Technical Meeting.

About development we made our forecasts:

- 1- We give money for new referees and it was a success in Bulgaria, Croatia and Greece. We are waiting for Armenia and Serbia for new referees.
- 2- We ensured the streaming of very good quality on the 2 major championships.
- 3- And we help many countries to organize championship.

To finish, it remains an anti-doping fund, so do not hesitate to ask some help for educational and antidoping actions.





Report from the Auditors Committee.

Mr. Xavier de Puytorac as a treasurer provided both, Mrs. Silva Katutyte and Mr. Pavol Müller as auditors, with all accounting documents and bank statements as a basis to perform the audit. Thus, through Dropbox tool used the whole accounting system was available for an accounting records evaluation and a comparison of moves on bank accounts, as well. Financial situation is presented in a simple accounting system.

No significant accounting failures affected 2019 year financial results were worked out. Anyway minor faults have been all corrected, of course.

Due to the system of issuing invoices from the preliminary nomination 6 450 EUR of anti doping fee and 7 740 EUR of participation fee have been collected from lifters who did not participate in the competitions in 2019. For this reason, the European region pays more to the IPF anti-doping fund than other regions.

On the basis of the audit we can confirm as follows:

The presented financial result is correct, it is based on accounting and it does correspond with the bank statements as in 31.12.2019. Within 31.12.2019 the current bank account status is 30 003,49 EUR and similarly, the saving account status within 31.12.2019 is 149 996,50 EUR, as well.

Last but not least we would like to thank Mr. Xavier de Puytorac for his hard work.

6) Secretary General Report

Dear Delegates, ladies and Gentlemen

Welcome member nations to the 2020 General Assemble, a big welcome to the EPF new family member Malta Powerlifting Federation, the European Powerlifting Federation continue to work hard in the development of Powerlifting in Europe. I'm pleased to report we had another very successful year, however this in turn increase the demand on the EC board daily duties.

European championships

Many thanks to all organizers of European Championships the standard is getting higher and higher each year. Now EPF organizer eight championships with the University Cup to come in 2020 we're finding it difficult to attract organizers, to try and reduce the number of championships and Cups the EC may have to combine some equipped and Classic championships. Due to the continue high number of athletes nominated for the European classic Open, Junior and Sub-Junior the EC decided from 2023 to split it into Junior and Sub-Junior in October and Open in December. EC will introduce a new procedure for Opening Ceremony each nation will be presented in alphabetic order by their nation flag with a representative picture on a big screen together with the speaker announcement this is because we're finding it difficult to get nations to send representative for the opening ceremony. From 2021 we will develop an EPF speaker pool to ensure each championships and Cup have good quality speakers. Addition to the victory ceremony

procedure the speaker will announce each athlete with their placing the athlete will make a step forward in acknowledgment

EPF strategic plan

EPF strategy plan 2019 to 2021 has been updated as our working document to bring the sport forward. **Mission**, to Introduce European University Cup in powerlifting in 2020 achieved, seek partnership with EUSA European University Sports Association ongoing, Work to include powerlifting into European Games ongoing.

Marketing

The EPF executive in cooperation with the EPF media team Eric Rupp and Richard Haywood have been working on a strategy to attract more sponsors. We're still looking for companies to come into dialogue to try to develop a range of different sponsorship deals. All members are encouraged to help find new sponsors to enhance the development of our great sport. The EC asked all member nations to please complete their yearly National Statistics this is very important for the EPF when discussing sponsorship with potential sponsors

EPF Media

The media team is working hard to increase the EPF present on social media also work with organizers to ensure European championships are represented on social media sites. High quality livestream continued to raise the profile of the sport to the general public from 2018 to 2019 it is more than doubled. 2 387 547 load downs in 2019 is a huge number. This proves that our audience is by streaming and not in the competition venue. You Tube has in 2019 the number of 327 036 hits while Facebook has 2 060 511 hits congratulation to the EPF media for the great work they are doing to promote the sport. From 2020 Goodlift will livestream with one or two cameras with the speaker as the commenter all other championships and Cups not high-quality livestream by Viva TV.

- Masters Powerlifting in Sibiu (Romania) and I was there in charge to coordinate a meeting with the Romanian Antidoping Agency.


Moreover, I am collecting:




Distribution of lifters in type of competitions


TECHNICAL COMMITTEE REPORT to Congress 2020

It is surprising at times when so few people turn up. Many feel that the naming of nominations, the bus timetable, and the time and price of the banquet are the only considerations. Not so !

There are many other important issues during the Technical Meeting that may be explained e.g. legality of equipment, rule anomalies, referee-jury duties...

The EPF EC has been focussed, together with the IPF EC and Rule Group, on the Technical Rules for made them more understandable and we continued to work for you all.

Any change will need to be a proposal to the IPF Rule Group.

With thanks to everyone who has already cooperated to this.

We shall continue to take the initiative and proactive approach working for the interests of our powerlifting family.


- Women's Committee Report


Dear Delegates and Member Federations,


In particular, the trend of the last ten years is shown in the following charts.

- EPF Championship Secretary Report.

In the past years the number of European and World championships and cups have increased significantly. There are one or two European or World Championships every month, and from 2020 the European University Cup is added to the list.

The task of the Championship Secretary is to ensure that major international events do not collide. If necessary, sanction may be refused in order to achieve an orderly calendar. With the increase in international events collisions between IPF and EPF championships are difficult to avoid.

The number of participants at the competitions, coaches and above all the need for referees have increased considerably. I would like to thank all officials for their effort and willingness to participate in this demanding and important function.

Getting a sufficient number of referees at the European Junior and Master Championships have been a problem. I would like to ask representatives of all European member federations to help us solve this problem.

Willingness to organize the championships are of great importance to the sport. I would like to thank the organizers for the important job they are doing for the sport and for the cooperation with the Championship secretary in 2019 and so far in 2020.

A few nations have unfortunately missed the Technical Meetings. The championship secretary underlines the importance of participation at these meetings. If a representative of a participating nation is absent from the Technical Meeting the Championship Secretary must be informed in advance. The confirmation of absence from the Technical Meeting must be sent between the date of the final nomination and the start of the Technical Meeting. The confirmation must also include final changes in the list of referees and the final nomination.

The nomination of lifters and officials to European championships should be received by the Championship Secretary with a copy to the Meet director. Currently this is done by sending the Team nomination forms in a Word-file to the Championships Secretary and to the organizer by mail. The same data have to be inserted into the Goodlift nomination online program on internet. This represent an unnecessary double reporting. From 2021 we plan to use the Goodlift system as the only system of nomination of lifters and officials to European championships.

• 105.7. Obligatory to stay in the meet hotel. (from EC))

All athletes, coaches, referees or officials from each federation must stay in the official hotel for all days in attendance of the championship. *Accreditation is issued in accordance with the number of hotel booking days.*

If athletes, coaches, referees or officials do not stay in the official hotel, they will be obliged to pay an administration fee of 100€ per person to the organizer. Failure to comply will have the effect they will not receive accreditation and will be excluded from that championship. All room bookings must be done *by the National Federation* through the meet director

Reason: To follow IPF rules.

• 103.2 (from EC)

...The participating national federations shall pay a doping test fee of EUR 50 for each lifter entered and declared at the preliminary final entry form. In addition to the doping test fee, participating national federations shall pay a participation fee of EUR 90 per lifter for each lifter entered and declared at the preliminary final entry form.

Reason: To follow IPF rules.

• **105.5.2** (from Slovak PF)

A national federation taking part in European championships and cups shall pay the EPF doping test fee and the participation fee for each lifter nominated and entered on the preliminary final entry form. No such fees are to be paid for nominated reserve lifters.

Reason:

At the moment the current rule is in conflict with the IPF constitution, causing problems to both, member federations and the athletes themselves, as well.

• 105.6 (from Slovak PF)

Actual version

Representation at the Technical Meeting.

All participating nations in European championships should be represented at the Technical Meeting. If a representative of a participating nation is not present at the Technical Meeting prior to the European championship or has not informed the EPF Championship Secretary about his/her absence by confirming the participation of his/her federation's nominated lifters (by e-mail or phone) a fine of 250 Euro will be imposed to the concerned national federation.

New proposed version

105.6 Representation at the Technical Meeting.

All participating nations in European championships should be represented at the Technical Meeting. If a representative of a participating nation was not present at the Technical Meeting prior to the European championship and there were any changes in his/her final nomination whilst EPF Championship Secretary was not informed about any changes for his/her federation's lifters nomination (by an e-mail or a phone) then the concerned national federation is to be charge by a fine of 250 Euro.

Reason:

As any competitor's transition to a different weight class is not allowed after the final nomination, the technical meeting only deals with problem of eventual competitor's absence.

It is pointless to penalize those federations that although have no changes in the final nomination only failed to report their absence at the technical meeting to the EPF championship secretary.

• **105.6** (alternative wording from EC if Slovak PF's proposal is accepted)

Representation at the Technical Meeting. All participating nations in European championships should be represented at the Technical

Meeting. If a representative of a participating nation is not present at the Technical Meeting prior to the European championship or has not informed the EPF Championship Secretary about his/her absence by confirming the participation of his/her federation's nominated lifters (by e-mail or phone) a fine of 250 Euro will be imposed to the concerned national federation if there are any changes in the national federation's nomination.

101.3 (from EC). To add at the end:

Constitutional and By-Law's changes accepted by the General Assembly are effective from 1. January the following year if not otherwise stated by the General Assembly or in the Constitution & By Laws.

Reason: This has been the procedure all years in EPF and IPF but not written in the Const. or BL.

• **105.13**.(from EC)

. If a referee(s) from that nation is not present or, if present, is not available to act in the capacity of either referee or member for jury at least two days during the championship/cup, the lifters are allowed to take part, but a fine of Euro 500 1000 has to be paid by the nation for each missing referee...

Reason: EPF needs referees to attend European championships. The level of the fine should stimulate the federations to send referees instead of paying the fine.
