4. President Report

On behalf of EPF I welcome delegates and guests to the 2024 General Assembly.

A special Thanks to the Croatian Powerlifting Federation, President Danijel Škopec and the Meet Director Dražen Moslavac for organising the General Assembly here in Velika Gorica, Croatia.

General overview

From being an amateur sport, powerlifting has grown into a highly respected and more professional sport. Powerlifting is in line, or even better than many Olympic sports and the economy in EPF has increased to a satisfactory level. This is good for our organizers, all athletes and officials.

All the planning and all the work to achieve such a progress and success, are thanks to many individuals both at the EPF administration, key persons in the federations and clubs and the athletes themselves. Demanding work year by year has made it possible for us to take small steps forward to get us where we are today.

Year 2023 was a normal year with respect to championships and number of athletes competing. But the war between Russia and Ukraine is a black shadow over Europe and harms the sport, people and the economy. Europe will not return to a normal condition before the war ends.

The financial situation for EPF is good. We finish 2023 with a slight deficit, close to eight thousand euro, but the bank deposits are 224 thousand euro. The incomes from the sponsors were 430 thousand euro. This is close to the amount of expenses in Sports Development and Media Marketing. This illustrates the importance of the sponsors for our sport.

I know that there have been discussions of the fees, especially the participation fee for coaches. The participation fee for each nominated lifter have been ninety euro for years, but we propose that the fees remain unchanged also in 2024. Regarding the participation fee for coaches, we need to have a clear definition of who is a coach and who is not. I know that IPF are working on this subject and will clarify this.

Strategic plan

The Strategic plan for 2021 to 2024 is a guideline for all EPF officials and member nations. The plan consists of five missions:

- Inspire to doping free powerlifting.
- Governing the EPF
- Organising events
- Sports development
- Promoting media and market involvement

The new Strategic Plan 2025 – 2028 will be presented at the GA.

Inspire to doping free powerlifting

All doping controls are the responsibility of IPF (CCES) both in competition at World and European championships and cups and out of competition. IPF focus now more on Out of competition testing as instructed by WADA, because this kind of testing can be done at any time throughout a year independent of championships.

EPF will continue the anti-doping work by promoting anti-doping seminars and our member federations should focus on anti-doping if they want powerlifting to reach IOC status.

Fair play and a healthy sport must be in focus.

In the budget for 2024 the suggestion is to increase the antidoping work with ten thousand euro.

Governing the EPF/Administration

The daily workload to run EPF are increasing year by year. The Executive board members are the ones who conduct most of the daily work. Today, we have people in the Executive with good qualifications and experience to perform all the necessary work. But all work has been voluntary, and the workload is close to a full-time job for some of the officials.

Tetiana Melnyk is doing an excellent job as a Secretary General, but we need to continue the work to be more professional in the administration and must move towards full-time job in the future for the Secretary General.

Thank you very much to the Executive Board members Xavier de Puytorac, Myriam Busselot, Sandro Rossi, Tero Hyttinen and Stéphane Hattot. Together with Tetiana Melnyk you all do a splendid work to run and administrate EPF.

Oleksandr Kopayev is our employed Computer Secretary. His efforts on computer programming and competition registration are a great part of running well organized championships. Since 2022 he has been supported by Alejandro Perez Garcia which has done a very good job.

Francisco Gutierrez is our photographer and Amelia Potter run the social media accounts of the EPF. They are doing a great job publishing pictures and stories on social media (FB/INSTA).

EPF's auditor, Silva Katutyte is doing a great job to control the EPF accounting together whit the professional auditor.

Organising events and sports development

The dedicated support from our sponsors in donated materials and economic contribution, strongly helps EPF to support our organizers and maintain the high activity. This also help us bring powerlifting forward.

The donated material of IPF recognised equipment to organizers of European championships and cups financed by the sponsors. Organizers of European championships and cups will receive:

1 Lifting Platform

2 sets Bars & Collars with a total of 535kg for each set

2 sets Powerlifting Racks

2 Disc Holders

1 bar lifter

1 Magnesia Container

The sport of powerlifting continues to grow. More lifters are attending championships every year. The demand for quality championships, professional spotting/loading teams, medical staff at championships, media coverage with quality streaming has increased greatly. With the help from all the powerlifting family I am sure that we will succeed in developing the sport to meet this demand.

In 2024 the support to the organisers of European championships and cups will increase. To make sure the lifters at the championship are safe we will provide support to organizers for professional spotters/loaders and give support to the organisers for having medical staff at championships.

In April 2024 we will be signing a memorandum of understanding, or MOU at the EUSA EC meeting

in Portugal, regarding EUSA Powerlifting Championship The first EPF EUSA Powerlifting Championship is scheduled for 2025 in Luxembourg, and it will be important step forward.

Promoting media and market involvement

We have high quality level streaming of the main European championships. This reaches people all over the World and a high number of followers are registered at all streaming we do.

The number of subscribers and followers in Facebook (26K), Instagram (19,1K) and YouTube (22,3K) have increased, but Twitter/X has given us less value and the activity is reduced.

EPF have the following sponsors: Rogue, SBD, Hansu Power, Maniak Fitness and Malta tourism. We also have a new contract with Eurosport and from 2025 we will have the European Open Classic Powerlifting Championship highlighted at Eurosport.

The Executive members, in co-operation with Emanuel Scheiber, Eric Rupp and Richard Haywood, work to line out all information needed to present EPF as an attractive partner for sponsors and collaborators.

Such information is necessary because any sponsor must know what benefit the company will get if the company puts money or resources into EPF. Any sponsor will look at the return of the investments.

The best lifters at both European and World Open championships according to IPF GL points, have every year since 1995 been awarded European Powerlifters of the year except for year 2020.

The lifters are appointed European Powerlifters of the year 2023, selected from the average highest IPF GL score at the Europeans Open and the Worlds Open:

• The EPF EC members will be responsible for the By-Laws and that the By-Laws are in line

with relevant regulations.

I hope we will have useful discussions and make good decisions at this General Assembly.

6. Treasurer's Report 2023

Dear Member Nations,

We have a new record with 41 members in 2023.

EPF continues its development and we are very proud of it.

We have a very good participation of 2217 lifters (without Russia and Belarus) instead of 2100 in the provisional budget. So we have 10 000 € more in Participation Fees.

It should be noted that the incomes from sponsors 430 431€ is almost equal to the amount of expenses in Sports Development and Media Marketing. These are the sponsors who financed our development in 2023 and we will continue this strategy in 2024.

As each year I show you the amount of the penalities, which equals 18 300 € in 2023. The good side of this is that we have the possibility to use this money for inviting more referees in 2024.

We used 12 023 € for additional referees in 2023.

We finish with a slightly negative balance of $7990.20 \in$, but we have a very good financial situation with $224491.01 \in$ at the EPF account.





9. Secretary General Report

Dear Representatives of the EPF Member Nations,

I want to start my report with the statement that this year for me was a year of learning, meeting new people, creating new contacts and connections, working on new projects and implementing new ideas. At first all the documents related to the organization of the EPF events were updated. These are the Promoter's Contract, Checklist, Invitation, Transport and Accommodation Form, etc.

This year we decided to revise and bring our Constitution and By-Laws to the good order according to the sport regulating major documents and IPF Constitution and By-Laws. The whole structure was

revised and in the consultation with a lawyer the substantial legislative basis for the EPF functioning was formed.

This year we also will present you the Strategic Plan of the development of the EPF for the next 4-year period, which will be aimed at the enforced attention payed to the marketing strategy, conducting of our social media accounts, elevating the level of the EPF events and setting up the new projects. In cooperation with the EPF marketing consultant Emanuel Scheiber, we negotiated good contracts with new Sponsors for our Federation, which allow us to increase the input into development of our events and the Federation in general.

The key new Contracts were signed with Eurosport and Malta Tourism. Starting from 2025 we will have the European Open Classic Powerlifting Championship highlighted at Eurosport.

With Malta Tourism we will have EPF events in Malta on a regular basis with the financial contribution of 120.000 Euro annually.

Our Partners continue to provide the equipment for the EPF events, uniform for the spotters and loaders, support EPF with their financial input, which allows to raise the level of the powerlifting championships in Europe and gives the opportunity for us to support the event Organizers substantially.

EPF Media strategy was revised and the new people were recruited to run the social media accounts of the EPF. I think that you have already noticed the changes and the responsible person for that now is Amelia Potter from Great Britain.

Amelia has joined the EPF as the Social Media Officer and conducts her work on providing the updated information on the upcoming EPF events and making posts on those, which were finished. In addition, she makes the sponsors related posts and stories, which allow us to provide more benefits for the partners and potentially elevate our requirements for the future contracts.

Last year we announced the casting for the Speakers and Commentators positions. Many candidates already have been tested at the EPF events during late 2023 and the beginning of 2024. And we found really good, professional, duly skilled people for these roles, who will contribute to the development of the EPF events conduction level.

In the terms of the streaming, we continue to cooperate with the Viva TV company and Eric Rupp.

In 2024 three EPF events are planned for the Viva TV streaming. These are:

European Open Classic Powerlifting Championship (Velika Gorica, Croatia 12-17/03/2024)

European Open, Junior and Sub-Junior Equipped Powerlifting Championship (Hamm, Luxembourg 07-12/05/2024)

European Sub-Junior and Junior Classic Powerlifting Championship (Plzen, Czech Republic 06-13/10/2024)

The new project we are working on is the EUSA Powerlifting Championship. It is a very serious and substantial portion of work, as at the beginning we have to set all the regulating documents, which will conform the requirements of both sides – EUSA and EPF.

In January, together with IPF FISU Delegate Emanuel Scheiber we had a meeting in the EUSA headquarters in Ljubljana with the EUSA Sports Manager Miha Zvan, EUSA Sports Administrator Aleksandra Andreeva and EUSA Sports Officer Eszter Gulyás, where we had a very fruitful workshop on the EUSA/EPF Championships.

As a result of this meeting, EPF and EUSA agreed on signing a MOU at the EUSA EC meeting in Portugal in April, 2024. This is a huge step forward.

The first EPF EUSA Powerlifting Championship is scheduled for 2025 in Luxembourg and it will be very important for all of us. Therefore, I urge you to get in the close contact with your respective NUSAs and in cooperation with them bring the students sport of powerlifting to the next level. It is very important to build up the successfully working communication between these organizations.

I believe that our general aim is to have powerlifting as the part of the European Games and we will work hard on the achievement of this final goal.

In addition, I did my best and continue keeping the close contact with all the Organizers of all the EPF events during this year for the best their conduction.

In line, I would ask all the EPF National Federations to inform me as a Secretary General about any changes in the board or any contact information to be used for keeping the effective and working connection.

11. Championship Secretary Report

The Championship Secretary shall ensure that major international events do not clash to achieve an orderly calendar. With the increase in international events it is difficult to avoid clash between IPF and EPF championships.

The sport of powerlifting is growing in popularity and the number of lifters attending championships are increasing every year. A consequence of this is long days during championships especially in classic powerlifting. Good examples are the European Classic Masters and the European Classic Junior & Sub-Junior Powerlifting Championships 2023 in Hungary, where weighing-in started at 7 a.m. and the last victory ceremony was at 10 or 11 p.m. We will add more days for most growing championships, but it takes some time, so I'm asking patience for this.

Another important issue concerning growth of our sport is that we have quite often A- and B-groups

at our championships. Especially in open classic powerlifting championships. To ensure fair play for

each lifter in these weight categories, the National Federations must nominate their lifters with the

correct results from past 12 months before preliminary nominations ends from national or

international championships. Result must have been done in the same weight category than lifter is

going to be nominated.

I would like to thank the organizers for the important job you are doing for the sport.

The organizers of the championships are of immense importance to the sport. Without the organizers

there would not be any championships.

I would also like to thank all the officials, and above all the referees, for their work and willingness

to participate in this demanding and important function. There is still a problem to get enough

referees, especially at the first part of European Junior Championships and at the Masters

Championships. I would like to ask representatives of all European member federations to help us

solve this problem. Without referees we are not able to organize championships that our great lifters

deserve.

There have been situations where nations have not attended Technical Meeting. All participating

nations should be present at the Technical Meeting. If a representative of a participating nation is

absent at the Technical Meeting, they must inform the Championship Secretary and Treasurer by

email. The confirmation of absence from Technical Meeting must be sent between the date of the

final nomination and the start of the Technical Meeting. The confirmation must include changes in

the list of referees and changes in the final nomination.

With hope that 2024 will bring greater compliance in the world to the three values of Olympism:

excellence, friendship, and respect.


13. Women's Committee Chairwomen Report

Dear Delegates of the Member Federations,



14. Outstanding Legal Matters

Ukrainian Powerlifting Federation Request

Case

1. Russian Powerlifting Federation has included, as its members, the regional powerlifting organisations which are under the authority of the Ukrainian Powerlifting Federation (UPF) (namely Crimea, Donetsk, Kherson, Luhansk and Zaporizhzhia regions), which constitutes a breach of the Olympic Charter because it violates the territorial integrity of the UPF in accordance with the Olympic Charter.

Russian Powerlifting Federation has established and registered the local sport federations at the occupied Ukrainian territories.

Request

To send the case to the IPF Court of Justice to further suspend the Russian Powerlifting Federation (RPF).

Background

Following the Article 1.3.5 of the IPF Constitution "In its activities, the IPF follows the Olympic ideals, principles, and beliefs and maintains the ideals and objectives of the Olympic movement as enshrined in the Olympic Charter, and established in the Olympic Agenda 2020 and its recommendations, the IOC Code of Ethics, the IOC Basic Principles of Good Governance of the Olympic and Sports Movement, the Olympic Movement Code on the prevention of the Manipulation of Sport Competitions, the IOC Guidelines relating to the creation of an IF Athletes' commission, the IOC Consensus of Sex Reassignment and Hyperandrogenism, the IOC Sustainability strategy, and the IOC Athletes Safeguarding Regulation."

International Olympic Committe Executive Board suspended Russian Olympic Committee with immediate effect after the analogic actions.

"The unilateral decision taken by the Russian Olympic Committee on 5 October 2023 to include, as its members, the regional sports organisations which are under the authority of the National Olympic Committee (NOC) of Ukraine (namely Donetsk, Kherson, Luhansk and Zaporizhzhia) constitutes a breach of the Olympic Charter because it violates the territorial integrity of the NOC of Ukraine, as recognised by the International Olympic Committee (IOC) in accordance with the Olympic Charter." – as stated in the IOC notice.

The Olympic status of neutrality invented for Russian sportsmen to return them to international level events means not supporting the actions of the Russian government.

RPF proved with many actions that it is not a neutral organization, which totally follows the policy of Russia. Such organizations must not function alongside with the civilized sport organizations, which want to operate in the spirit of peace, respect, and unity.

16. Proposals

16.1 EPF EC Proposal

To adopt the EPF Constitution and By-Laws in the new version as two separate documents, which are in line with the IPF Constitution and By-Laws and the Norwegian law on the non-profit organizations.

16.2 Switzerland Powerlifting Federation (Kraftdreikampfverband Schweiz) Proposal

To change Article 105.7 of the EPF By-Laws

Actual version (valid after March 1st 2024):

105.7 Obligatory to Stay in the Meet Hotel

All accredited athletes, coaches, officials and referees nominated by their national federation for the European event, must stay in the official hotel(s) designated by the organizer. An accreditation badge shall not be issued to a nominated athlete, coach, official or referee that is not staying in the hotel. Additionally, the issued credential shall match the number of days they will be officially participating in the event. If an athlete, coach, referee or official does not stay in the hotel, they shall not receive accreditation and shall be excluded from the event. All room bookings must be done by the National Federation through the meet director, unless otherwise specified on the entry form.

New proposed version:

105.7 Obligatory to Stay in the Meet Hotel

All accredited athletes, coaches, officials and referees nominated by their national federation for the European event, must stay in the official hotel(s) designated by the organizer. An accreditation badge shall not be issued to a nominated athlete, eoach or official or referee that is not staying in the hotel. Additionally, the issued credential shall match the number of days they will be officially participating in the event. If an athlete, eoach, referee or official does not stay in the hotel, they shall not receive accreditation and shall be excluded from the event.

If coaches or referees do not stay in the official hotel, they will be obliged to pay an administration fee of 100€ per person to the organizer. Failure to comply will have the effect they will not receive accreditation and will be excluded from that championship.

All room bookings must be done by the National Federation through the meet director, unless otherwise specified on the entry form.

Reason: Mandating an official hotel for athletes who are staying at events for a few days has plausible reasons. However, the often expensive hotels add another entry barrier for much needed volunteers (coaches and referees) that are often staying for a whole week. This is especially problematic for nations that receive no monetary funding and cannot pay the expenses of their team coaches and referees.

16.3 Proposal from the Danish Powerlifting Federation on behalf of the Nordic Powerlifting Federation

Registration of European Records set at Nordic Powerlifting Championships

Motivation:

NORDIC POWERLIFTING FEDERATION – NPF – is an organization founded on February 23, 1975. The federation is composed of the affiliated Nordic National Federations governing the sport of powerlifting based on one national federation per country. In the by-laws it is stated that the NPF is sanctioned by the EPF.

NPF shall follow the rules defined by the International Powerlifting Federation (IPF). The NPF consists of 6 nations. Denmark Sweden, Norway, Finland, Iceland, and the Faroe Islands joined in 2022. At the Nordic Championship 2023 155 lifters participated.

The championships comply with the IPF technical rulebook, and international referees are regularly examined at NPF Championships as well.
